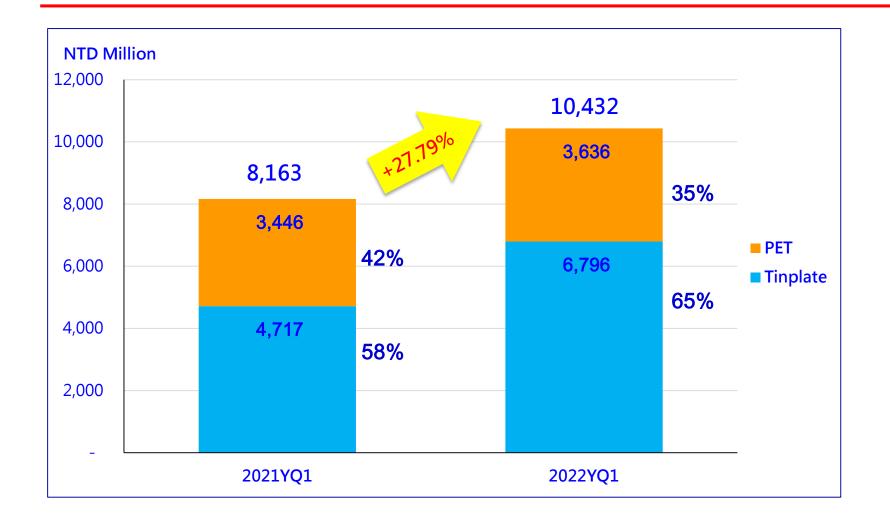

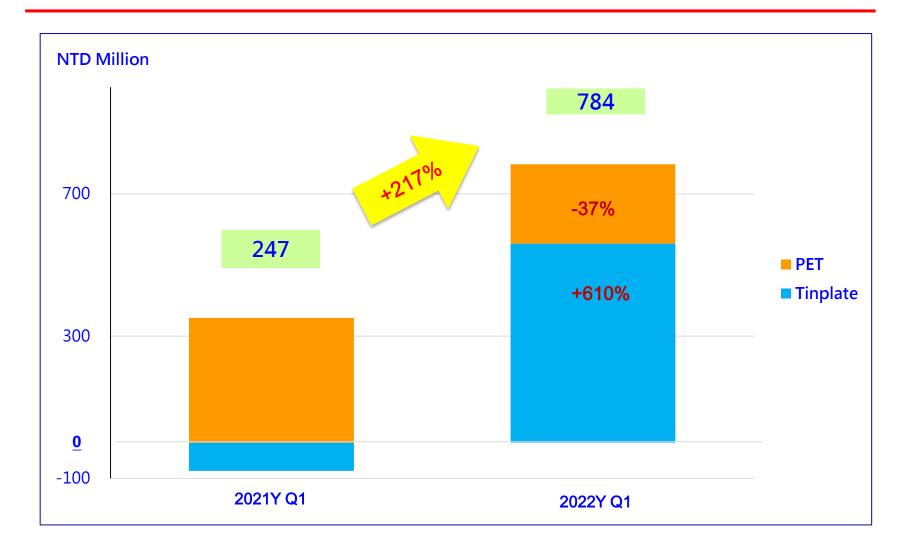


Segment Revenue

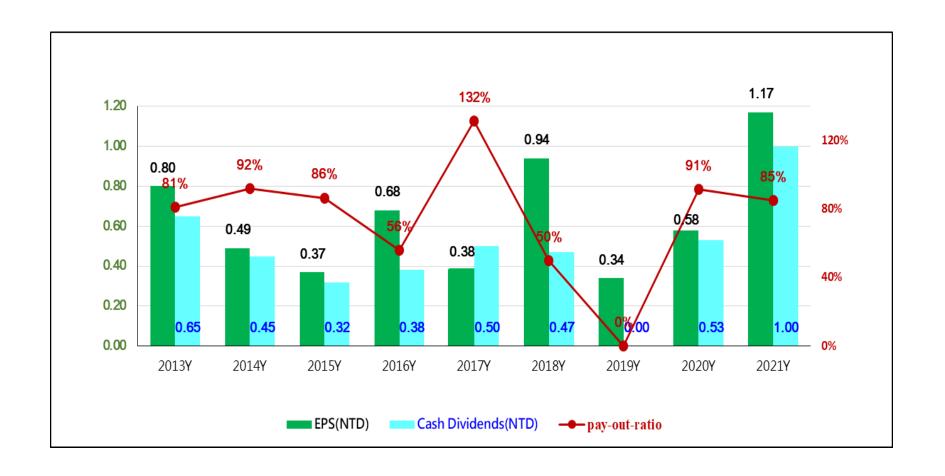
