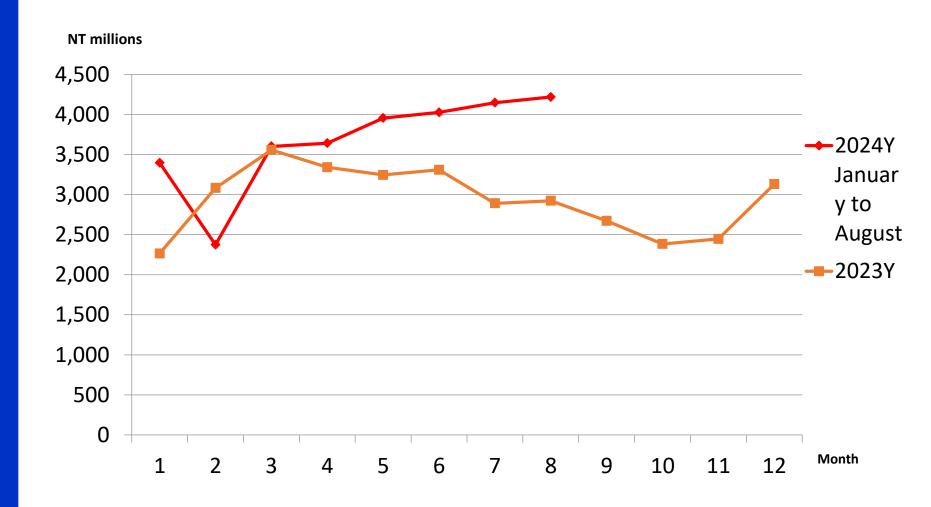

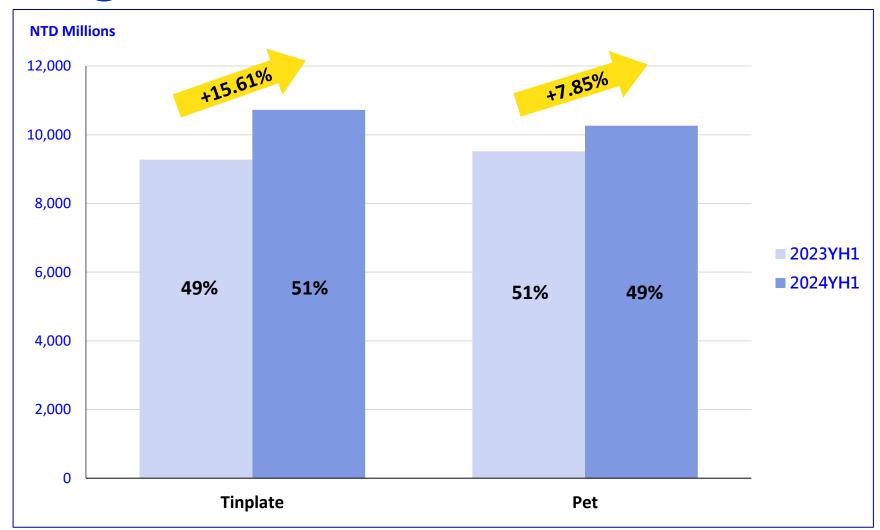


Consolidated Revenue Comparison (2024Y January to August \ 2023Y)



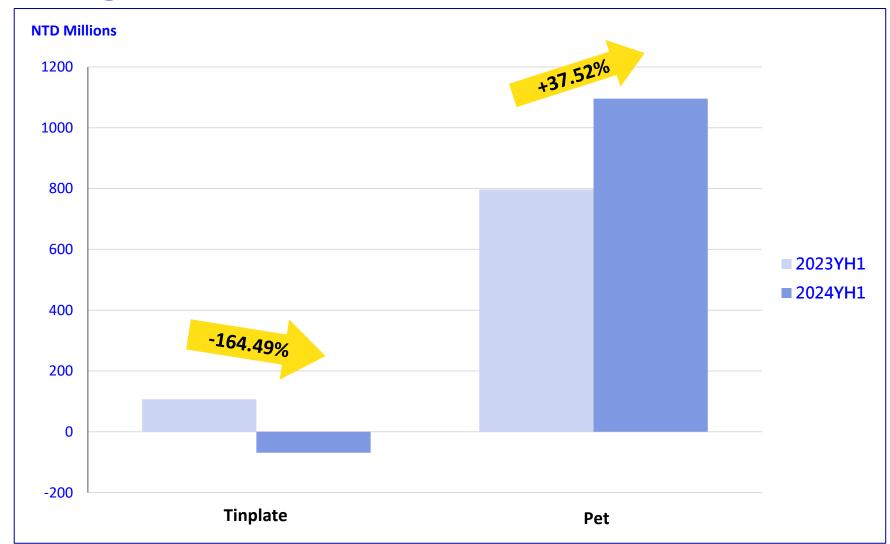

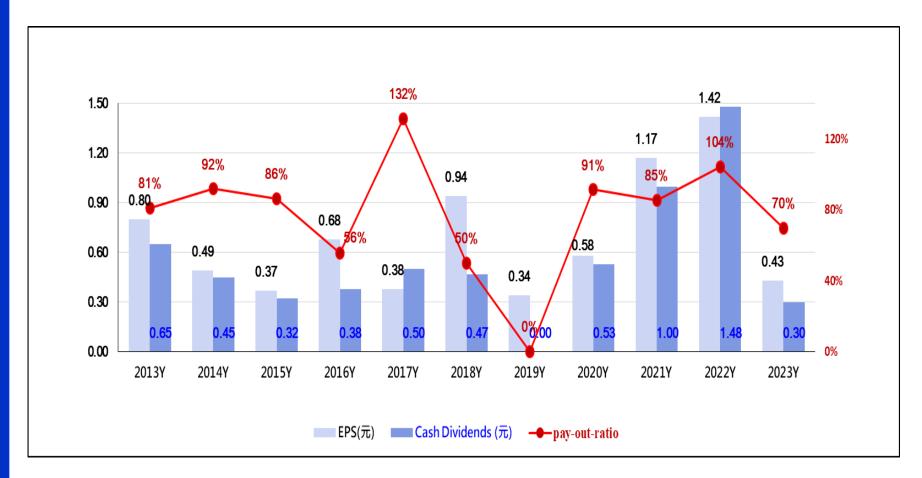

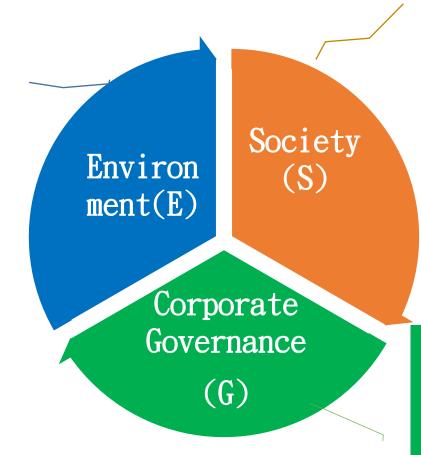
