



Revenue Comparison(consolidated) (2024Y 1-11 vs 2023Y)





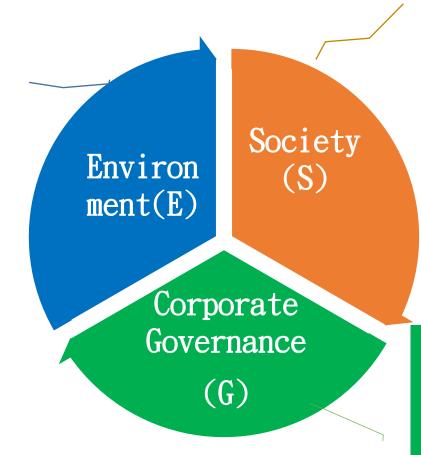
